Unpacking a Lifetime of Trauma



At just ten years old, Kelsey had accumulated a lifetime of emotional trauma, suffering through emotional and physical abuse from her stepfather.

Fortunately, Kelsey's custody was given to her local social services. They arranged for Kelsey to be adopted by a loving family. Unfortunately, Kelsey still retained the pain of the psychological trauma she endured from her early childhood. It left her constantly feeling helpless, lost, and worthless.

Before arriving to Jackson-Feild, Kelsey had received community-based mental health services and two placements at other residential psychiatric treatment centers. Her family realized that she needed a specialized trauma-focused program that provided treatment services for children suffering from PTSD (post-traumatic stress disorder).

Once Kelsey came to JFBHS, her therapist helped her process her trauma and advocated for her treatment needs. On multiple occasions, her therapist helped Kelsey communicate her feelings to her parents in family therapy sessions. Through her healing process, Kelsey processed her trauma and learned positive coping skills she could utilize when bad memories from past trauma resurfaced.

Far and away, Kelsey's biggest takeaway from her time with JFBHS was how she improved her self-image. When she arrived, Kelsey had a negative perception of herself. This drastically impacted both her understanding of self and her ability to interact positively with others. As she progressed through her healing journey, she found herself more at ease, both in her own presence and in the presence of others.

JFBHS provided Kelsey with the opportunity to develop skills to assist her in processing, managing, and coping with traumatic experiences from her past. Furthermore, the insights she gained throughout her stay helped her better understand how her past experiences continued to negatively impact her well-being and her worldview. Finally, the knowledge she gained through her collaborative psychoeducation with her therapist helped Kelsey examine why she sought to use negative and ultimately self-harming behaviors in an attempt to seek short-term relief.

Following her successful completion of her residential treatment, Kelsey returned home to live with her parents and pursue her new, bright future. Kelsey is an intelligent and energetic young lady who feels good about herself and is confident of her future. While she was always blessed with artistic talent, she now has the opportunity and drive to fulfill her dream of attending art school to become an artist.

Kelsey, like many of our children, encountered horrific experiences with which she didn't know how to cope. The combination of a trauma-focused treatment model with experienced and caring staff helps children like her to overcome their trauma in order to heal so that they can have fulfilling and productive lives.

A LETTER FROM NANCY PHILPY, DIRECTOR OF BUSINESS DEVELOPMENT

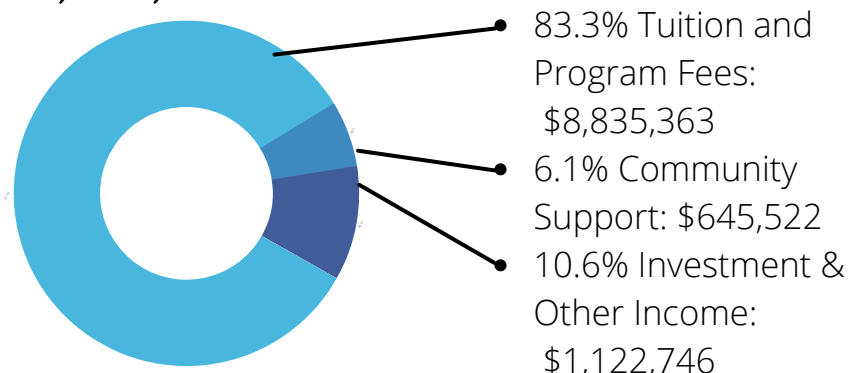

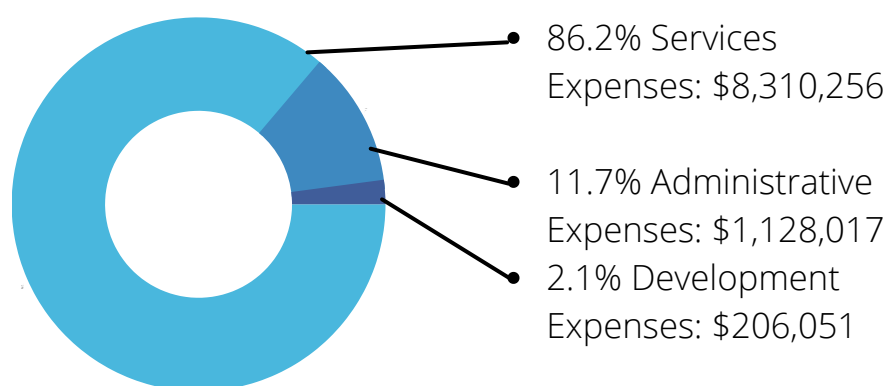

2022 CONSOLIDATED OPERATING INCOME AND EXPENSES

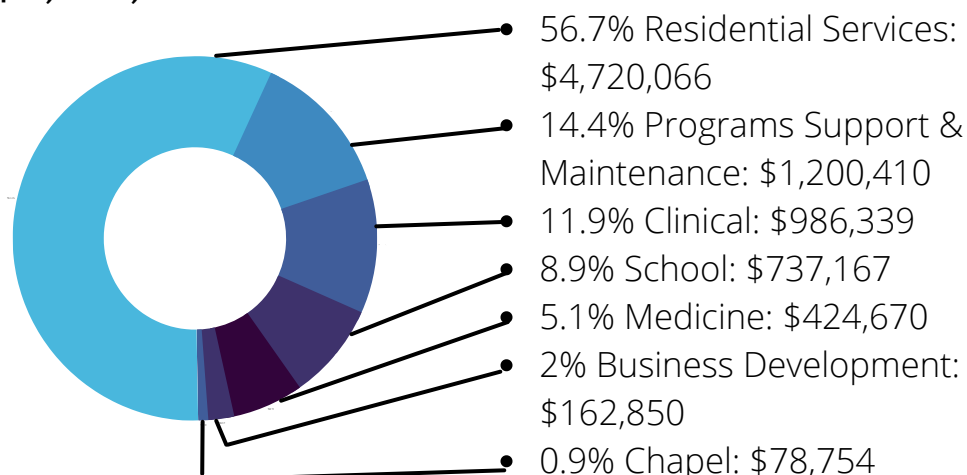
CONSOLIDATED REVENUE – OPERATIONS AND FOUNDATION – \$10,603,631

An independent audit was conducted by Keiter CPAs in accordance with generally accepted auditing standards. Total Net Assets for 2022 were \$6,806,146. A copy of the audit is available upon request and on our website. These figures represent the consolidated financial data for Jackson-Feild Homes and the Jackson-Feild Homes Foundation. Investment assets are used to fund capital purchases and improvements, provide scholarship funding for children with no financial resources, and to support special projects.
